Pursuant to the recommendations of the Departmental Promotion Committee (DPC) constituted vide Government Order No. 115- GAD of 2019 dated 23.01.2019 in furtherance of SAC Decision No. 166/22/2018 dated 07.12.2018, held on 15.07.2019 and in continuation to Government Order No. 09-JK(Edu) of 2023, dated 06.01.2023, sanction is hereby accorded to the regularization/promotion of following I/c Chief Education Officers as Chief Education Officers and I/c Lecturers as Lecturers (Botany) in the School Education Department in the pay grade applicable at relevant point of time, revised from time to time, as per the details shown against each:-

The above promotion/regularization is subject to the following conditions:

1. The above promotions shall be without prejudice to the outcome of any writ petition(s), if any, pending consideration before the competent court(s) of law.
2. The seniority of these officers shall be notified as per rules, separately.

3. In respect of Lecturers, the genuineness of PG Degree certificates/Institutions from where the degree has been acquired shall be ascertained by the concerned Directorates, keeping also in view the UGC guidelines issued from time to time regarding validity of the degrees and that the degree has been acquired after availing leave and proper permission from the competent authority.
4. The concerned Drawing and Disbursing Officers shall obtain an undertaking in the shape of an affidavit duly attested by the 1st Class Magistrate to the effect that if the service particulars/PG Degree certificate is found fake / forged / tempered or issued by un-recognized University or if the course is proved to be un-recognized at a later stage, he/she shall have no claim, whatsoever, and the promotion shall be deemed to be treated as cancelled ab-initio, without further notice. The Drawing and Disbursing Officers shall be responsible for implementation/fulfillment of conditions ibid.
