Regularization of I/c Lecturers in the discipline of Political Science, Urdu, Physics and English in School Education Department.

Government Order No: 33 - JK (Edu) of 2023.

Dated: 03.02.2023.

Whereas, vide Government Order No. 2163-JK(Edu) of 2022, dated 28.11.2022 regularization orders were issued in favour of (57) I/c Lecturers of various disciplines like Political Science, Urdu, Physics & English.

Whereas, among others Mr. Rajesh Saraf, I/c Lecturer in the discipline of Physics was also regularized on the recommendations of the Departmental Promotion Committee in its meeting held on 11.08.2021. The incumbent was figuring at Serial No. 46 of the Annexure to the said Government Order (bearing Seniority No. 11 in the discipline of Physics).

Whereas, after issuance of above said Government Order a representation/complaint was received by the Department stating therein that Mr. Rajesh Saraf has acquired his PG Degree in Physics discipline through distance mode from MP Bhoj University Bhopal and similarly placed candidates have been left-out.

Whereas, in the minutes of the DPC meeting held on 11.08.2021, the committee had recommended regularization of the incumbent because he was inadvertently figuring in the Table-B, wherein the committee had decided to issue regularization orders in favour of the incumbents having PG in regular mode only after satisfactory vigilance clearance is received in their favour from concerned quarters.

Whereas, on examining the seniority list of PG Masters/Teachers in the discipline of Physics issued in the year 2020 vide Government Order No. 156-Edu of 2020 dated 09.07.2020, it was found that Mr. Rajesh Saraf was figuring at Serial No. 11 has acquired his PG Degree through distance mode from MP Bhoj University Bhopal in the year 2008 and that too during service.

Whereas, Mr. Rajesh Saraf should actually have been figuring in Table-C of the said minutes of DPC, wherein the committee had decided that candidates who have pursued PG through Distance mode will be considered only after the concerned Directorates will verify their PG Degrees in light of the Government Order No. 252-HE of 2012 dated 30.05.2012 and 940-Edu of 2017 dated 17.11.2017 and recommended the candidates whose PG degrees are found valid / genuine in the verification shall be considered for

regularization.

Whereas, the Department has decided to review all placements made in the year 2019 to ascertain genuineness of PG degrees obtained through distance mode in Science Stream in light of Government Order No. 252-HE of 2012 dated 30.05.2012 and 940-Edu of 2017 dated 17.11.2017. Besides, recommendations from the concerned Directors are required for considering inclusion of such candidates in the seniority lists and subsequent promotion / regularization.

Wheras, the verification report/recommendations are still awaited from the Director School Education, Jammu/Kashmir in respect of all such incumbents figuring under Table-C of the minutes of the DPC meeting held on 11.08.2021.

Now, therefore, pending verification of PG Degree acquired through Distance mode in light of Government Order No. 252-HE of 2012, dated 30.05.2012 and 940-Edu of 2017, dated 17.11.2017, the regularization order issued vide Government Order No. 2163-JK(Edu) of 2022 dated 28.11.2022 under endorsement No. Edu-HRM/267/2021-01-SED (C.No.89803) in favour of Sh. Rajesh Saraf, I/c Lecturer in the discipline of Physics at Serial No. 46, is hereby withdrawn ab-initio.
