Whereas, Sh. Tejpal Singh (SC), I/c ZEO Kalakote Rajouri (working as I/c Principal) submitted a representation and requested for his regularization as Headmaster from the date his junior counterparts including Sh. Tarseem Lal (SC) have been regularized;

Whereas, seniority list of Masters (worked/working as I/c Headmasters) was issued vide Government Order No. 218-Edu of 2012, dated 02.08.2012 in which Sh. Tejpal Singh did not figure while the junior counterpart Sh. Tarseem Lal was figuring at S.No. 2385;

Whereas, vide Government Order No. 334-Edu of 2013, dated 19.03.2013, seniority of Sh. Tejpal Singh was fixed at 2383-A;

Whereas, the case file of Sh. Tejpal Singh was discussed in the DPC meeting held on 16.05.2023 (Supplementary Agenda, Item No. 1), and it was decided to regularize the incumbent as Headmaster w.e.f. 10.10.2008 i.e. from the date of eligibility, date of placement and availability of vacancy as per GAD Order No. 743-GAD of 2008, dated 28.06.2008;

Now, therefore, in light of the above decision of DPC meeting held on 16.05.2023, Sh. Tejpal Singh is regularized as Headmaster w.e.f. 10.10.2008 on regular basis.
