1. The officers shall report to the concerned Chief Education Officers within 10 days from the date of issuance of this order and in case of failure to join within the stipulated period, his/her assignment shall be deemed to have been cancelled ab-initio without any further notice.

- 2. It shall not confer any preferential claim or right to the Officer for seeking regularization / confirmation which shall be considered strictly as per set procedure and clearance by PSC/ DPC.
- 3. It shall be subject to the outcome of writ petition(s), if any, pending before any Court(s) of law.
- 4. The Officers shall submit an undertaking to the concerned CEO stating therein that in case his/her service particulars/academic credentials /PG Degrees are found fake/forged/tampered or issued by an unrecognised University, his / her assignment shall be deemed to have been cancelled ab-initio. Besides, any Officer from ZEO Cadre without PG Degree shall not be allowed to join the assignment and the same be conveyed to Administrative Department through concerned Directorate.
- 5. The assignment is purely temporary and in the interest of administration. These officers can be transferred at any point of time, for which no officer shall have right to claim.

It is further ordered that the officers assigned the look-after charge of shall exercise Drawing and Disbursing Powers in addition to Principals Administrative powers.
