Subject: O.A NO. 61/1160/20233 titled Pardeep Singh V/s UT of J&K & Ors.

Government Order No. 400-JK (Edu) of 2023
Dated: 05-12-2023

Whereas, vide Notification No. 01-JK (Edu) of 2023 Dated 26.04.2023, online representation were invited from various teaching cadres of Education Department including the Lecturer Cadre for consideration of transfer during the year 2023 and in response, representation of Pardeep Singh was received by the Department through Online Transfer Portal;

Whereas, the representation of Pardeep Singh was considered under the provisions of the Transfer Policy issued by the Department vide Government Order No. 103-JK(Edu) of 2023 dated 24.0.2023 and subsequently, the applicant, Mr. Pardeep Singh, Sr. Lecturer, Urdu working at HSS Gandoh, Doda (Zone-5) was transferred and posted at HSS Keshwan, Kishtwar (Zone-3) vide G.O No. 286-Jk(Edu) of 2023 dated 01.09.2023.;

Whereas, Pardeep Singh pursuant to his transfer filed OA No. 1160/2023 titled Pardeep Singh Vs UT of J&K & Ors before the Hon'ble Central Administrative Tribunal, Jammu praying for following reliefs:-

- I. Quashing impugned transfer Order no.286-JK (Edu) of 2023 dated 01.09.2023 issued under endorsement No.Edu-Lect./84/2023-01 dated 01.09.2023 to the extent of transfer of applicant from HSS Gandoh Doda to HSS Keshwan Kishtwar, whereby and where under the applicant who has been working as a lecturer in Urdu stream in HSS Gandoh Doda Zone-V which is very hard zone and has been transferred to HSS Keshwan Kishtwar, Zone-III which is at a distance of more than 150 Kms away from his present of posting in violation of Transfer Policy notified vide Govt. Order No.103-JK (Edu) of 2023 dated 24.04.2023 and instructions notified vide notification No.1 JK (Edu) of 2023 dated 26.04.2023 and also in violation of Schedule 1-D of CSR.
- II. Direct the respondents to allow the applicant to continue at his present place of posting i.e, HSS Gandoh Doda till the disposal of the O.A.
- III. Direct the respondent No.2 to explain how the applicant has been transferred in violation of transfer policy notified in terms of Govt. order

No.948-JK (GAD) of 2020 dated 15.10.2020 and transfer policy dated 24.04.2023 and without obtaining the approval of Chief Secretary and the instruction conveyed by the Chief Secretary and order or direction directing upon the Chief Secretary U.T. of J&K to conduct a full dressed inquiry against the respondent No.2 who has defied the instructions issued in terms of meeting note dated 10.03.2023 with impunity.

Whereas, the Hon'ble CAT after hearing the applicant, disposed of the OA by passing order dated 08.09.2023, the operative part of which is reproduced as under:

"..... Accordingly, the Original Application is disposed of with a direction to the Principal Secretary to Government, of school Education, Union Territory of Jammu & Kashmir to decide the applicant's representation dated 02.09.2023 and pass a reasoned and speaking order while keeping in view the provisions of Clause-C(ii) of the transfer policy dated 26.04.2023. Before taking such a decision, the applicant shall also be afforded an opportunity of hearing. The whole exercise shall be undertaken within a period of ten days from the date of receipt of a certified copy of this order.

So long as the applicant's representation remains pending the Principal Secretary to Government, of School Education, Union Territory of Jammu & Kashmir, the applicant shall be permitted to work at Government Higher Secondary School, Gandoh.

Ordered accordingly.

However, there shall be no orders so as to costs."

Whereas, in compliance to the directions of the Hon'ble Central Administrative Tribunal, vide letter dated 22.09.2023, the applicant was requested to appear in the Administrative Department for hearing on 25.09.2023. The applicant appeared on the scheduled date and time and the applicant was heard in person and was also allowed to submit his written statement as well;

Whereas, in his written statements, the applicant has stated that he has been transferred from HSS Gandoh, Doda (Zone-5) to HSS Keshwan, Kishtwar (Zone-3) vide G.O No. 286-Jk(Edu) of 2023 dated 01.09.2023. The applicant has submitted his choices as Jammu (Zone 1), Jammu (Zone II), Doda (Zone I) and Kishtwar (Zone I). The applicant has been serving in zone V of Bhalessa and has desired to continue/serve in zone V and no replacement has been provided in place of him and he has requested that he may be retained at HSS Gandoh, Doda or may be placed as per his choices;

Now, therefore, in light of the above stated facts and circumstances, the claim of the applicant has been considered in light of the directions passed by the Hon'ble Central Administrative Tribunal, Jammu on 08.09.2023 passed in



O.A NO. 61/1160/20233 titled Pardeep Singh V/s UT of J&K & Ors and his request for retention at HSS Gandoh, Doda (Zone V) is accepted and therefore the applicant has been retained at HSS Gandoh, Doda (Zone V).
