Sanction is hereby accorded to the authorization alongwith advance drawal of **Rs. 121.03 lakh (Rupees One Crore Twenty One Lakh Three Thousand Only) as UT Matching Share (Recurring)** in favour of **Project Director, Samagra Shiksha J&K (Nodal Officer PM Schools for Rising India)** for its utilization during the current financial year 2023-24 under the Centrally Sponsored Scheme "**PM-Schools for Rising India**" as per the BEAMS orders issued by Finance Department as mentioned under reference.

The release of funds is subject to the fulfilment of the codal formalities, procedural norms and following conditions:-

- i. All codal formalities shall be observed while incurring the expenditure.
- ii. The funds shall be utilized for the specific purpose/activities for which these have been released through BEAMS after fulfilling all codal formalities.
- iii. The funds shall neither be parked nor diverted in any case.
- iv. The conditions stipulated in BEAMS orders may be adhered to in letter and spirit.
- v. Chief Accounts Officer concerned shall vouchsafe availability of funds.
- vi. The utilization of funds shall be strictly as per the guidelines/approved action plan of the scheme.
- vii. The Project Director, Samagra Shiksha J&K (Nodal Officer PM Schools for Rising India) shall send Utilization certificates well before 31-03-2024 to GoI with a copy to Finance Department and Administrative Department.
- viii. Project Director, Samagra Shiksha J&K (Nodal Officer PM Schools for Rising India) shall incur expenditure strictly as per the guidelines of scheme/approved action plan of the scheme.
- ix. The Advance drawl should be as per actual and urgent need and should not result in parking of funds.

- x. Red account/Utilization Certificates of the funds be submitted by Project Director, Samagra Shiksha J&K (Nodal Officer PM Schools for Rising India) to Administrative Department for onward submission to Accountant General.
- xi. The Department shall send a status report about the scheme, in terms of physical and financial progress made during the current year and upto date cumulative expenditure and physical achievement.
- xii. Project Director, Samagra Shiksha J&K (Nodal Officer PM Schools for Rising India) shall incur expenditure strictly as per the work code description/conditions mentioned in the BEAMS order.
