Subject: CPSW No.368/2017 in SWP No. 908/2007 titled Amina Nag Vs Alok Kumar.

Government Order No: 449- JK(Edu) of 2023

D a t e d: 19-12-2023

Whereas, the petitioner, Amina Nag filed writ petition bearing SWP No: 908/2007 titled Amina Nag Vs State of J&K & Ors before the Hon'ble High Court; and

Whereas, the said writ petition was disposed of by the Hon'ble High court vide its order dated: 17.07.2010, the operative part whereof is reproduced as under:-

*".... In view of the above, without formally admitting the instant petition respondents are directed to treat the instant writ petition as representation on behalf of the petitioner for according consideration. Needless to say that while doing this exercise the respondents would fairly take into account that if the petitioners case is genuine one in terms of aforesaid govt. order dated 04.04.2003 her right is not snatched. Let needful be done within three months from the date copy of the order is made available to the concerned, which shall be the responsibility of the petitioner only. The petitioner shall also make the copy of the writ petition along with all annexes attached thereto available to the concerned authorities so that no delay is caused in completing the exercise.*

*Writ petition stands disposed of in the aforesaid terms alongwith connected CMP(s)."*

Whereas, in the year 1998, applications were invited for Class-IV posts from eligible candidates of Jammu Division and a committee of the following officers was constituted by the Director School Education, Jammu vide Order No: DSEJ/901-17 dated: 8-8-1998 to make selections:-

1. Chief Education Officer of concerned district.
2. Principal DIET of concerned district
3. One member from SC/ST community of the level of Principal HSS from same district to be jointly nominated by the Chief Education Officer and Principal DIET of the concerned district.
4. One officer to be nominated by Administrative Department

Whereas, the said committee was directed to submit its recommendation to the Director School Education Jammu after the completion of the interview process. However, the appointment orders were issued by the Chief Education Officer, Jammu, Kathua, Poonch, Udhampur and Rajouri in contravention to the prescribed procedure and the Director School

Education, Jammu vide his Order No. DSEJ/Gen/7566-7826 dated 28-6-99 cancelled all the appointment orders issued by the said Chief Education Officers of Jammu Division. When the matter came up before the Administrative Department, the Administrative Department kept in abeyance the order of the Director School Education, Jammu, dated 28-6-99 vide Govt. Order No. 906-Edu of 1999 dated: 05-07-1999 and;

Whereas, later on the aforementioned Government order was withdrawn vide Government Order No: 309-Edu of 2000 dated: 24-4-2000 resulting in the revival of the Director, School Education, Jammu's order No: DSEJ/Gen/7566-7826 dated: 28-6-1999. Aggrieved by this order, which in effect cancelled their appointment, many of the ousted appointees approached the Hon'ble High Court through writ petitions seeking re-appointment in service and the Hon'ble High Court, while upholding the cancellation of the appointments, directed that a fresh merit list be drawn by the Government keeping in view the fact that some of the candidates may be on the verge of crossing the age barrier. The said direction were passed in writ petition No: SWP-2668/1999 on 23-5-2000; and

Whereas, vide Govt. Order No: 556-Edu of 2002 dated: 11-4-2002, it was ordered that the ousted Class-IV employees shall be considered for appointment against the vacancies in the districts to which they belong temporarily on consolidated salary of Rs. 1200/- per month till such time the fresh merit list is drawn on completion of the selection process; and

Whereas, subsequently, the candidates working against Class-IV posts on consolidated salary of Rs. 1200/- per month were placed in the regular pay scale of Rs. 2550-3200 vide Government Order No: 383-Edu of 2003 dated: 4-4-2003 by the Department; and

Whereas, a writ petition titled Basharat Hussain and others was filed by 17 candidates challenging the Government orders No: 383-Edu of 2003 Dated:4-4-2003 and No:556-Edu of 2002 Dated: 11-4-2002 and the Government considered the cases of petitioners. Subsequently, a large number of writ petitions were filed in the Hon'ble High Court wherein Govt. Order No: 556-Edu of 2002 dated: 11-4-2002 and Govt. Order No: 383- Edu of 2003 dated: 4-4-2003 were challenged and the Hon'ble High Court after clubbing various writ petitions passed the following directions on 31-12-2007:-

*"I, however, leave the matter to the official respondents to consider the cases of the petitioners on the parity of the petitioners in Basharat Hussain's case. In case the Government decides to do so and the petitioners grievances are redressed the present writ petition shall be deemed to have been disposed of accordingly. The govt. shall take a decision in the matter within three months from the date copy of this judgment is served on the state. In case the Govt. does not take any decision in the matter within the said period or if the Govt. decides not to accord the said treatment to the petitioners, the petitions shall stand allowed and the orders impugned in the petitions No. 556-Edu of 2002 dated 11-4-02 and No. 383-Edu of 2003 dated 4-4-03 shall stands quashed".*

Whereas, the Department filed an LPA bearing No: 49/2008 against the aforesaid judgment before the Hon'ble High Court. The Division Bench of the Hon'ble High Court disposed of the LPA on 30-7-2009 with the following directions to the State:-

*"In the circumstances for all practical purposes, it must be deemed that by a way of a policy decision, the State Govt. created 417 more posts and in those posts, by the order dated: 4-4-2003 those 417 persons who were*

*permitted to work on temporary basis by the order dated: 11-4-2002, were regularized. In consequence, thereof, it must be deemed that there are still 417 posts available.*

*The number of writ petitioners is less than 417. Accordingly, all of them can be accommodated. There will, therefore, be no occasion to take re-course to up settling the orders of the Government dated: 11-4-2002 and 4-4-2003.*

*In the circumstances, the exercise to be undertaken in terms of the judgment and order under appeal be completed within a period of six months from today and to that extent the judgment and order under appeal is modified with clarifications”.*

Whereas, the matter was examined by the Department and it was decided to consider the appointment of such of the petitioners against Class-IV posts whose cases have been clubbed by the Hon'ble High Court. Accordingly, a proposal for creation of 67 posts in District Poonch was submitted to the Finance Department, which however did not agree to the Department's proposal. The matter was re-examined in the Department and with the prior approval of the Hon'ble Education Minister, the proposal for creation of 67 Class IV posts in District Poonch and appointment of 243 petitioners whose cases have been clubbed with lead case titled Adil Akhter and others V/S State and others was submitted to the Cabinet. The Cabinet approved the proposal of the Department vide its Decision No:85/05/2010 dated: 29-3-2010 and accordingly, vide Government Order No. 438- Edu of 2010 dated 30-4-2010 and Order No: 440-Edu of 2010 Dated: 13-5-2010, sanction was accorded to the creation of 67 posts of Class IV in District Poonch and utilization of said posts for appointment of the petitioners in clubbed writ petitions with lead case titled Adil Akhter Vs. State and others and the posts so created shall stand abolished as and when such incumbent shall retire, resign, dies or gets promoted; and

Whereas, the case of the petitioner has been examined by the Department and it has been found that in terms of the Jammu and Kashmir School Education, Subordinate Service Recruitment Rules, 2008 notified vide SRO-308 dated: 16-10-2008, the method of recruitment for the post of Class-IV is as under:-

*“50% by direct recruitment.  
50% by selection from Middle pass Contingent Local paid employees by committee duly constituted for the purpose by the concerned Director School Education”.*

Whereas, the petitioner in the instant case has neither been selected nor recommended by any Board, as such they cannot be appointed against Class-IV posts in terms of rules in vogue; and

Whereas, the records further reveals that the Department in compliance with the Hon'ble High Courts direction dated: 30-7-2009 considered the cases of petitioners whose writ petitions

were clubbed with lead case titled State of J&K V/S Adil Akhter and others (LPA (SW) No: 49/2008) and appointed them against the Class-IV posts vide Government Order No: 440-Edu of 2010 dated: 13-5-2010 based on Cabinet Decision No: 85/05/2010 dated: 29-3-2010. However the petitioners in the instant case approached the Hon'ble High Court after a period of many years and that too when the Department have already issued appointment order in favour of the candidates who were petitioners in clubbed writ petitions with lead case titled Adil Akhter and others V/S State and others; and

Now, therefore, in compliance to the Hon'ble High Courts direction dated: 17.07.2010 passed in SWP No: 908/2007 titled Amina Nag vs State of J&K & Ors, the claim of the petitioners for appointment against Class-IV posts has been considered and found not in consonance with the rules and, hence rejected accordingly.
