Subject: **Posting of Lecturers awaiting adjustment.**

**Government Order No. 59 - JK (Edu) of 2023.**

**Dated: 23.02.2023.**

Whereas, on the recommendations of Departmental Promotion Committee (DPC) in its meeting held on 11.08.2021, I/c Lecturers in (06) six disciplines were regularized as Lecturers and accordingly after receipt of vigilance clearance in their favour, regularization orders were issued by the Department; and

Whereas, the regularization orders so issued, were subject to certain conditions among which one condition was that the genuineness of PG degree certificate / Institutions from where the degree has been acquired shall be ascertained by the concerned Directorates, keeping also in view the UGC guidelines issued from time to time regarding validity of the degrees and that the degree has been acquired after availing leave and proper permission from the competent authority; and

Whereas, after issuance of regularization orders, some Lecturers represented before the Department for their posting/adjustment as Lecturer as in some institutions the posts of Lecturers were not available; and

Whereas, the case was examined in the Department and matter was taken up with the Director School Education, Kashmir/Jammu vide letter dated 28.01.2022, wherein they were requested to furnish the list of Lecturers of various disciplines who have been regularized by the Department but their posting as Lecturer is pending and they are still working against the posts of Masters/Teachers; and

Whereas, in response, Director School Education Kashmir vide his communication No. DSEK/Estt-I/1537/2411, dated 30.03.2022 furnished details of Lecturers of various disciplines who are awaiting their posting / adjustment; and

Whereas, while going through the information provided by Director School Education Kashmir, among others following Lecturers **(who have done their PG Degree before entering the service)** and have been regularized on the recommendations of DPC in its meeting held on 11.08.2021 are still awaiting their adjustment/posting orders:
