Pursuant to the recommendations of the Departmental Promotion Committee (DPC), constituted vide Government Order No. 115- GAD of 2019 dated 23.01.2019 in furtherance of SAC Decision No. 166/22/2018 dated 07.12.2018, held on 15.07.2019, sanction is hereby accorded to the regularization/promotion of I/c Chief Education Officers as Chief Education Officers and I/c Lecturers as Lecturers (Botany) in the School Education Department in the pay grade applicable at relevant point of time, revised from time to time, as per the details shown against each in the list forming Annexure to this Government Order with effect from the dates indicated against each subject to the following conditions:-

- 1. The above promotions shall be without prejudice to the outcome of any writ petition(s), if any, pending consideration before the competent court(s) of law.
- 2. The notional effect to the promotions, wherever indicated, shall not entitle the Officers for grant of any monetary benefit/drawal of arrears and shall be for purposes of seniority only.

3. The seniority of these officers shall be notified as per rules, separately.

- 4. In respect of Lecturers, the genuineness of PG Degree certificates/Institutions from where the degree has been acquired shall be ascertained by the concerned Directorates, keeping also in view the UGC guidelines issued from time to time regarding validity of the degrees and that the degree has been acquired after availing leave and proper permission from the competent authority.
- 5. The concerned Drawing and Disbursing Officers shall obtain an undertaking in the shape of an affidavit duly attested by the 1st Class Magistrate to the effect that if the service particulars/PG Degree certificate is found fake/forged/tempered or issued by un-recognized University or if the course is proved to been un-recognized at a later stage, he/she shall have no claim, whatsoever, and the promotion shall be deemed to be treated as cancelled abinitio, without further notice. The Drawing and Disbursing Officers shall be responsible for implementation/fulfillment of conditions ibid.
