Subject: Technical resignation of Mr. Subash Kumar, Lecturer Economics HSS Dool, Kishtwar.

WHEREAS, Mr. Subash Kumar was appointed as Lecturer Economics in the School Education Department vide G.O No.955-Edu of 2017 dated 24.11.2017;

And WHEREAS, pursuant to advertisement Notification No. 429-PSC/DR/2023 dated 17-05-2023 issued by J&K Public Service Commission, Mr. Subash Kumar applied for the post of Assistant Professor (Economics) through proper channel as an in-service candidate;

And WHEREAS, vide letter No. Edu/303/2023-01 dated 03.10.2023 the application form of the lecturer was forwarded to the Secretary, J&K Public Service Commission;

And WHEREAS, Mr. Subash Kumar was appointed as Assistant Professor Economics in the Higher Education Department vide Government Order No. 79-JK(HE) of 2024 dated 16-02-2024;

And WHEREAS the lecturer, Mr. Subash Kumar, tendered his technical resignation through the medium of a representation dated 26.02.2024 before the Principal Govt. Higher Secondary School Dool, Kishtwar pursuant to his appointment as Assistant Professor in Higher Education Department;

And WHEREAS, Director School Education, Jammu vide letter No. DSEJ/Gaz/Lect/17390-91 Dated 19-07-2024 forwarded the technical resignation case of the lecturer for its acceptance;

And WHEREAS, Article-201 of the Jammu and Kashmir Civil Services Regulations Volume-I lays the following provision in this regard;

"Resignation of an appointment to take up another appointment in which service counts, is not to be held to be a resignation of the Government service, provided the consent of the former departmental superior is obtained to accepting, such employment."

NOW THEREFORE, the technical resignation tendered by Mr. Subash Kumar, Lecturer Economics HSS Dool, Kishtwar, is hereby accepted w.e.f 26-02-2024 on his own request. Consequently, his lien in the Jammu and Kashmir School Education (Gazetted) Service shall be deemed to have been terminated from the said date.
