The above placement is temporary and shall not confer any preferential right on the aforesaid officials to hold these posts on substantive basis or claim promotion, which shall be made in accordance with the extant rules in the DPC as per set procedure (inconsonance with eligibility, seniority, availability of vacancy in light of Government Order No. 743-GAD of 2007, dated 28.06.2007) and shall be subject to the outcome of writ petition(s), if any, pending in the Court of Law.

Besides, the above placement is further subject to the following conditions:

- (i) The I/C Lecturers shall join their new place of postings within a period of 21 days from the date of issuance of this order, otherwise it shall be construed that they have foregone their new assignment and action as warranted under rules shall follow.

- (ii) The DDOs shall draw and disburse their salaries only after verification of Degrees from concerned quarters and after satisfying himself/herself regarding genuineness of PG Degrees in accordance with relevant Government Orders.
- (iii) The postings of the officials shall also remain subject to the condition that the Universities/Institutions from which they have obtained their degrees are recognized as per UGC guidelines and are DEC/AICTE approved.
