GOVERNMENT ORDER NO: - 295 - JK (Edu) of 2025

Whereas, the applicant has filed Original Application before the Hon'ble Central Administrative Tribunal, Jammu Bench, seeking following reliefs in the matter:

- Commanding and directing the respondents to quash the Government Order No. 327-JK (Edu) of 2023, dated 09.10.2023 whereby the applicant who is working as Master in the office of respondent No.4 has been promoted as In-charge Lecturer in the discipline of Mathematics and is adjusted in High Secondary School Panassa, Reasi.
- Quash the relieving order dated 12.10.2022 whereby the applicant has been relieving from the office of respondent No. 4 and is directed to report to Government Higher Secondary School Panassa, Reasi.
- Commanding and directing the respondents to retain the applicant on the post of In-charging lecturer in any of the Higher Secondary Schools Jammu on the ground that the applicant has already served in zone-III and is now entitled to serve in Zone-I clubbed with the facts that the applicant is due to retire/superannuate within a period of two years.

Whereas, the Hon'ble Central Administrative Tribunal vide its order dated 25.07.2024 has disposed of the Original Application with following directions:-

"...Looking to the limited prayer made by the learned counsel for the applicant, the O.A. is disposed of, at the admission stage itself, without going into the merits of the case, with direction to respondents to treat a copy of this O.A. as representation of the applicant and decide the same by passing a reasoned and speaking

order. The whole exercise shall be completed within a period of four weeks from the date of receipt of a certified copy of this order.


With the above directions, the O.A. stands disposed of.

No order as to costs."

Whereas, the case of the applicant has been thoroughly examined by the department, and upon such examination, it has been found that, under Government Order No. 327-JK(Edu) of 2023, dated 09.10.2023, among others, Smt. Jasmeen Chowdhary was appointed as Incharge Lecturer in the discipline of Mathematics. The applicant was listed at Serial No. 107, Seniority No. 565 in the aforementioned order. The placement order as Incharge Lecturer (Mathematics) was issued subject to the following conditions:

1. It shall not confer any preferential claim or right to the officials for seeking regularization/confirmation which shall be considered strictly as per set procedure and clearance by DPC/PSC and shall be subject to the outcome of writ petition(s), if any, pending before the Court(s) of law.
2. The incumbents(s) shall join at new place of posting(s) within seven (07) days, failing which it shall be presumed that he/she has forgone the placement and the same shall be cancelled ab-initio.
3. The CEO concerned shall ascertain the genuineness of the PG degrees and ensure that same are valid and obtained from Universities/Institutions recognized by the UGC/AICTE.
4. The I/c Lecturer(s) shall submit an undertaking to the concerned Chief Education Officer stating therein that in case his/her service particulars/academic credentials are found fake/forged / tampered or issued by an unrecognized university or the course is proved unrecognized at any stage, he/she shall have no claim on the placement and same shall be cancelled ab-initio without any further notice.

Whereas, despite the applicant joining her new place of posting as Incharge Lecturer under Government Order No. 327-JK(Edu) of 2023, dated 09.10.2023, the applicant submitted a representation on 13.12.2023 seeking modification, which was not accepted. Subsequently, she applied to forgo her promotion, citing multiple health issues and her age being over 55 years.



Now, therefore, in consideration of the above-stated facts and circumstances, the applicant's claim for modification or further adjustment as Incharge Lecturer has been evaluated in accordance with the directions issued by the Hon'ble Central Administrative Tribunal, Jammu, on 25.03.2024, in O.A No. 61/770/2024 titled *Jasmeen Chowdhary Vs UT of J&K & Ors.* After careful review, the claim has been found not tenable under the applicable rules and is hereby rejected.
