Whereas, General Administration Department vide O.M No. GAD(Vig)90-RDA/2016 dated 21.11.2016 had forwarded a copy of letter No. VO-Veri PR-31/2014-13616-17, dated 29.09.2016 along with all the relevant documents as received from the Vigilance Organization for initiation of RDA against Shri Mohammad Ashraf Chouhan, the then CEO Poonch and others in accordance with J&K Civil Services (Classification, Control and Appeal) Rules 1956; and

Whereas, the matter was examined in the Department and vide Government Order No: 199-JK (Edu) of 2023 dated 06.07.2023, Shri Mohd Ashraf Chouhan, the then CEO Poonch (now deceased) has been exonerated from all charges leveled against him in case verification No. PR-31/2014; and

Whereas, the fresh vigilance clearance in favour of Late Mohd Ashraf S/o Late Kaka Chouhan has also been received through the General Administration Department vide Form No. 209459; and

Whereas, in the DPC meeting held on 15.07.2019, Mohd Ashraf (now deceased) I/c Chief Education Officer was also recommended for regularization as Chief Education Officer, in the relevant pay scale, as revised from time to time, **with effect from 01.11.2012**, but the regularization order was not issued in his favour due to RDA initiated against him under verification No. PR-31/2014;

Now therefore, on the recommendations of the Departmental Promotion Committee constituted vide Government Order No. 11-GAD of 2019 dated 23.01.2019, sanction is hereby accorded to the regularization of **Mohd Ashraf** (now deceased) I/c Chief Education Officer as **Chief Education Officer**, in the relevant pay scale, as revised from time to time, **with effect from 01.11.2012** subject to the following conditions:-
