- i. **Project Director, Samagra Shiksha J&K (Nodal Officer PM Schools for Rising India) shall persue with Department of School Education & Literacy, Ministry of Education, Gol for early release of Centre Share.**

- iv. The expenditure shall be made strictly in accordance with GFR 2017.

- vi. The funds shall be utilized after following due e-tendering procedure as provided under rules.
- vii. Chief Accounts Officer, concerned, J&K shall vouchsafe availability of funds.
- viii. The utilization of funds shall be strictly as per the guidelines/approved action plan of the scheme.

- ix. The Project Director, Samagra Shiksha, J&K (Nodal Officer PM Schools for Rising India) shall send Utilization certificates well before 31-03-2024 to Gol with a copy to Finance Department and Administrative Department as well.
- x. The Advance drawal shall be as per actual and urgent need and should not result in parking of funds.
- xi. The Department shall send a status report about the scheme, in terms of physical and financial progress made during the current year and upto date cumulative expenditure and physical achievement.
- xii. Project Director, Samagra Shiksha, J&K (Nodal Officer PM Schools for Rising India) shall incur expenditure strictly as per the work code description/conditions mentioned in the BEAMS order.
