Subject: Withdrawal of regularization order in respect of Sh. Narinder Singh, retired Principal DIET Samba.

> Government Order No: 143-JK (Edu) of 2024. Dated: 29.02.2024.

Whereas, Sh. Narinder Singh, retired Principal DIET Samba submitted a representation dated 26.08.2022 requesting for correction of his date of regularization as Chief Education Officer; and

Whereas, the case was examined and vide this Department's letter dated 16.02.2023, the Director School Education Jammu was requested to furnish authenticated service particulars of Sh. Narinder Singh, retired Principal DIET Samba; and

Whereas, the Director School Education Jammu vide communication No. DSEJ/Gaz/6549 dated 06.03.2023 furnished the service particulars of the said officer; and

Whereas, the case has been examined viz-a-viz the eligibility list of I/c CEOs determined for regularization/ promotion as Chief Education Officer, following details emerge in respect of the instant case:

Name: Narinder Singh.
Date of Birth: 01.09.1955.
Date of Retirement: 31.08.2013.
Date of Regularization: 01.03.2013.

Whereas, the meeting of the Departmental Promotion Committee for considering regularization of I/c CEOs as CEOs was held on 15.07.2019, wherein the case of Mr. Narinder Singh for regularization as Chief Education Officer has been given regularization effect w.e.f. 01.03.2013; and

Whereas, as per eligibility list of I/c CEOs for their regularization as CEOs, the Date of Birth of Mr. Narinder Singh was wrongly entered as 01.09.1955 instead of 08.03.1954. The incumbent retired on superannuation w.e.f. 31.03.2012 on the basis of his actual date of birth. Further, it reflects that the vacancy which was utilized for regularization of Mr. Narinder Singh accrued on 01.03.2013; and

Whereas, since the vacancy accrued on 01.03.2013 as per eligibility list and Mr. Narinder Singh retired on 31.03.2012, then the incumbent should be treated to have retired

before accrual of vacancy and the regularization order as CEO, issued in his favour is required to be rescinded; and

Whereas, after thorough examination it has been decided to withdraw the regularization / confirmation order issued in favour of Mr. Narinder Singh, retired Principal DIET Samba issued vide Government Order No.2035-Edu of 2022 dated 01.08.2022; and

Now, therefore consequent upon above facts, it is hereby ordered that the regularization /confirmation order issued in favour of Mr. Narinder Singh, retired Principal DIET Samba vide Government Order No.2035-Edu of 2022 dated 01.08.2022 is withdrawn ab-initio.
