- ii. In case of an adverse report from ACB/GAD (vigilance) or any concerned agency, his/ her assignment shall be deemed to have been cancelled ab-initio.
- iii. The officers shall join/report their new place of posting (s) **within 07 days** from the date of issuance of this order and in case of failure to join within the stipulated time period, his/her assignment shall be deemed to have been cancelled ab-initio without any further notice.
- iv. The officers shall submit an undertaking to the concerned Director stating that in case his/her service particulars/academic credentials are found fake/forged/tempered or issued by an un recognized university, his/her assignment shall be deemed to have been cancelled ab-initio.
- v. The above arrangement shall be without any prejudice to the outcome of writ petition(s), if any, pending consideration before any Court(s) of law.

It is further ordered that the officers shall exercise Drawing and Disbursing Powers in addition to Administrative Powers.
