The release of funds is subject to the fulfilment of the codal formalities, procedural norms and following conditions:-

- All codal formalities shall be observed while incurring the expenditure.
- 2. The funds shall be utilized strictly for the purpose these have been released and strictly as per the approved plan.
- 3. No diversion/re-appropriation of funds is allowed at any level.
- 4. The Project Director, Samagra Shiksha, J&K (Nodal Officer PM Schools for Rising India) shall send Utilization Certificates well before 31-03-2024 to GoI with a copy to Finance Department and Administrative Department.
- 5. Chief Accounts Officer/Financial Advisor concerned shall vouchsafe availability of funds.
- 6. The Advance drawal should be as per actual and urgent need and should not result in parking of funds.

- The funds needs to be mandatorily credited to the respective SNA Account in view of the instructions that all the expenditure under CSS is to be incurred from the SNA Account only as PFMS will not accept treasury data of Non-SNA releases with effect from 01-12-2022.
- 8. All the conditions stipulated in BEAMS order shall be adhered to in letter and spirit.
- The Project Director, Samagra Shiksha J&K (Nodal Officer PM Schools for Rising India) shall incur expenditure strictly as per the guidelines of scheme and conditions laid down in the sanction letter of Ministry of Education, GoI.
- Red Account/Utilization Certificates of the funds be submitted by Project Director, Samagra Shiksha to Administrative Department for onward submission to Accountant General.
- 11. The accounts and other records shall be open to inspection by an Officer of the Ministry of Education or any other person deputed by Ministry for this purpose.
- 12. The Department shall send a status report about the scheme, in terms of physical and financial progress made during the current year and upto date cumulative expenditure and physical achievement.
- 13. The Project Director, Samagra Shiksha J&K (Nodal Officer PM Schools for Rising India) shall incur expenditure strictly as per the work code description/conditions mentioned in the BEAMS order.
- 14. The Scheduled Caste Component, Scheduled Tribes Component and General Component-wise details need to be incorporated in utilization certificate separately.
