Subject: O.A No. 848/2023 titled Zahoor Ahmad Vs UT of J&K & Ors.

Government Order No. 22 -JK (Edu) of 2024

**Whereas**, vide Notification No. 01-JK (Edu) of 2023 dated 26.04.2023, online representations were invited from various teaching cadres of Education Department including the Lecturer Cadre for consideration of transfer during the year 2023 and in response, representation of Zahoor Ahmad was received by the Department through Online Transfer Portal;

**Whereas**, Zahoor Ahmad, pursuant to his transfer, has filed O.A No. 848/2023 titled Zahoor Ahmad Vs UT of J&K & Ors before the Hon'ble Central Administrative Tribunal, Srinagar praying for following reliefs:

- i. Directing the non-applicants to consider the representation of the applicant for transfer the applicant from HSS Kislay, Bandipora, Block Gurez to a School in his home District i.e. Ganderbal strictly in terms of transfer policy notified vide Government Order No. 103-JK(Edu) of 2023 dated 24.04.2023 and on account of medical conditions of her daughter;

**Whereas**, the Hon'ble CAT after hearing the applicant disposed of the OA by passing order dated 31.10.2023, the operative part of which is reproduced as under:

**"...Heard the learned counsel for the parties who submits that he would be satisfied that if the OA is disposed of at the pre-admission stage with the direction upon the respondents to consider the representation filed by the petitioner on 26.09.2023 wherein the petitioner has projected his grievance, in accordance with merits and in the process the petitioner be heard in the matter and it is expected that the petitioner will co-operate with the respondents, the same be done within a period of 08 weeks from the date of the copy of this order is served upon the respondents"**

**Whereas**, in compliance to the directions of the Hon'ble Central Administrative Tribunal, Srinagar. The applicant was heard in person through video conferencing. The applicant requested to transfer him to a suitable place in his home district i.e Bandipora in view of the health condition of her daughter who is suffering from Life Threatening disease namely Takayasu (Vasculitis) with left artery thrombosis, a condition where the patient is always at risk of stroke and the Doctors have strictly advised for close monitoring and regular treatment and follow up and have cautioned that this disease may prove fatal, if not properly treated and take care of;

**Whereas**, the case of the applicant was thoroughly examined in the Department and in light of the directions of the Hon'ble Central Administrative Tribunal and it has been found that the case is covered under the policy in view of the life threatening disease of her daughter;

Now, therefore, in light of the above stated facts and circumstances, the claim of the applicant has been considered in light of the directions passed by the Hon'ble Central Administrative Tribunal, Srinagar on 31.10.2023 passed in O.A No. 848/2023 titled Zahoor Ahmad Vs UT of J&K & Ors and the applicant is hereby transferred and posted at BHSS, Chateergul, (Zone III) Kangan. This transfer shall not give him any preferential right over his promotion and his promotion shall remain subject to the outcome of the OA No. 1207/2022 filed before the Hon'ble Central Administrative Tribunal, Srinagar. The applicant is further directed to immediately join at new place of posting without any further delay, failing which strict disciplinary action shall be initiated against him under rules
