Subject: OA No.1491/2023 titled Rohit Khajuria V/s UT of J&K & Ors.

**Government Order No. 23 -JK (Edu) of 2024**

**Dated: 05-01-2024**

**Whereas**, vide Notification No. 01-JK (Edu) of 2023 dated 26.04.2023, online representations were invited from various Teaching Cadres of Education Department including the Lecturer Cadre for consideration of transfer during the year 2023 and in response to the representation of Sh. Rohit Khajuria was received by the Department through Online Transfer Portal;

**Whereas**, the representation of Rohit Khajuria was considered under the provisions of the Transfer Policy invited by the department vide Government Order No. 103-JK(Edu) of 2023 dated 24.0.2023 and subsequently, the applicant, Rohit Khajuria, Lecturer, was transferred from HSS Pallan Kathua, (Zone IV) to HSS Kotli Bagga Reasi;

**Whereas**, Rohit Khajuria pursuant to his transfer filed OA No.1491/2023 titled Rohit Khajuria V/s UT of J&K & Ors before the Hon'ble Central Administrative Tribunal, Jammu praying for following reliefs:-

- i. Appropriate directions may be issued to the respondent No.1 to post the applicant in Zone-I of Jammu District.

**Whereas**, the Hon'ble CAT after hearing the applicant disposed of OA by passing order dated 20.11.2023, the operative part of which is reproduced is as under:

**".....Accordingly, the Original Application is disposed of with a direction to respondent no. 1 to decide the pending representation of the applicant dated 18.09.2023 by passing a reasoned and speaking order within a time frame and communicate the order so passed to the applicant. Before taking such a decision, the applicant shall be afforded opportunity of hearing. The whole exercise shall be undertaken within a period of three weeks from the date of receipt of a certified copy of this order.**

**With these directions, O.A. No. 1491 of 2023 is disposed of. It is made clear that I have not entered into the merits of the case. However, there shall be no orders so as to costs."**

**Whereas,** in compliance with the directions of the Hon'ble Central Administrative Tribunal, the applicant was requested to appear in the Administrative Department for hearing on 24.11.2023. The applicant appeared on the scheduled date and time and the applicant was heard in person and was also allowed to submit his written statement as well;


**Whereas,** in his written statements, the applicant has stated that he has been transferred from HSS Pallan Kathua, (Zone IV) to HSS Kotli Bagga Reasi. The applicant joined at HSS Kotli Bagga Reasi and requested for his modification on spouse posting who is working as medical officer in the Health Department and is posted at SDH R.S. Pura. The applicant further stated that singhhe has served in Zone IV for more than five years and was transferred to HSS Kotli Bagga Reasi. The Department again modified his transfer and he is again retained at HSS Pallan, Kathua. The applicant further requested that he may be posted in his home district, keeping in view, the posting of his spouse as well as his stay in the hard zone (Zone IV) in district kathua as per the criteria notified by the Department. His request for posting in Jammu District cannot be considered in view of the vacancy position. However, his modification can be considered in nearby District, keeping in view his stay in hard zone (Zone IV) HSS, Pallan, Kathua as well as the posting of his spouse in District Jammu ;

Now, therefore, in light of the above stated facts and circumstances, the claim of the applicant has been considered in light of the directions passed by the Hon'ble Central Administrative Tribunal, Jammu on 20.01.2023, passed in OA No.1491/2023 titled Rohit Khajuria V/s UT of J&K & Ors ,the applicant is hereby transferred and posted at DIET, Samba.
