**Subject:** Withdrawal of regularization order in respect of Ab. Jabbar Bhat,  
Retired Headmaster.

**Government Order No: 230-JK(Edu) of 2024.**

**Dated: 17.05.2024.**

**Whereas,** Director School Education, Kashmir vide communication dated 25.10.2023 has submitted that Date of Birth of Mr. Ab. Jabbar Bhat, Retired Headmaster has wrongly been shown as 05.06.1954 instead of 05.06.1952 and recommended for necessary rectification;

**Whereas,** Mr. Ab. Jabbar Bhat was regularized as Headmaster vide Government Order No.205-JK(Edu) of 2023 dated 08.07.2023, figuring at S.No.7, Sty No.313 in the said order. The regularization effect in his favour was given as Regular w.e.f. 01.12.2011 upto the date of retirement;

**Whereas,** the case was examined as per the service records and supporting documents provided by the Director, School Education, Kashmir, which reveals that date of birth of ex-official is 05.06.1952;

**Whereas,** Mr. Ab. Jabbar Bhat had superannuated on 30.06.2010 and his retirement predates the vacancy accrued on 01.12.2011;

**Whereas,** as a matter of fact against the accrued vacancy on 01.12.2011, Mr. Ab. Jabbar Bhat, cannot be regularized as Headmaster;

**Whereas,** on thorough examination of the case, it has been decided that the regularization order issued in favour of Mr. Ab. Jabbar Bhat is to be treated as null and void ab-initio;

**Now,** therefore, it is ordered that the regularization/confirmation order issued in favour of Mr. Ab. Jabbar Bhat, figuring at S.No.7, Sty. No.313 in the Government Order No.205-JK(Edu) of 2023 dated 08.07.2023 is hereby withdrawn ab-initio.
