In continuation to Government Order No. 05-JK(Edu) of 2024 dated 04.01.2024 and on the recommendations of the J&K Services Selection Board, sanction is hereby accorded to the appointment of Mr. Liyaqat Ali Kasana S/o Fareed Ahmad Kasana R/o Anantnag against a Class IV (MTS) post in District Cadre, Anantnag in the Pay Level SL-1 (14800-47100), notionally w.e.f. 04.01.2024.

The above appointee shall report to the office of the Chief Education Officer, Anantnag, within a period of twenty one (21) days from the date of issuance of this order failing which he shall forego the right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:-

- i. Academic/Qualification Certificate.
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate issued by the Competent Authority.
- v. Valid relevant Category Certificate, if any applicable.

The appointment of the above candidates shall further be subject to the following conditions:-

- i) The appointee shall furnish an Undertaking in the shape of an Affidavit as per **Annexure-A** to this Order.
- That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Cer.tre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the

4654724/2024/0/0 Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- The salary of the appointees shall not be drawn and disbursed to him unless iii) the satisfactory report in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate is received from the concerned Authorities/Agency.
- The appointees shall be on probation for a period of two years. iv)
- The appointment of the candidates shall be governed by the "New Pension V) Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- The inter-se-seniority of the appointees in the J&K School Education vi) (Subordinate) Service shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956 as well as merit of J&K SSB.
- The appointment of the above appointees shall be cancelled ab-initio, if it is vii) found that they possess higher qualification than the prescribed one at any stage and they shall also be liable for criminal prosecution under law.
- The appointment of the above appointees shall be subject to outcome of writ viii) petition(s), if any, pending before Competent Court of Law.
