Whereas, the applicant Sanjeev Jamwal has filed Original Application before the Hon'ble Central Administrative Tribunal at Jammu wherein prayed as an under:-

- i. To direct the respondents to consider the case of the applicant for regularization as lecturer as computer science w.e.f 2009 restore the seniority of lecturer w.e.f 2009 as well as of senior lecturer and grant all consequential service benefits attached to the aforesaid post w.e.f 2009 in the interest of justice.

Whereas, the Hon'ble Central Administrative Tribunal vide its order dated:- 24.11.2022, has disposed of Original Application with the following direction:-

*".....I have considered the submissions made by the Ld. Counsels for both the sides and perused the material on record. Without expressing any opinion on the merits of the case, the O.A. is disposed of at admission stage with direction to respondents to treat a copy of this O.A. as representation of applicant and take a decision on the same, as per relevant rules and other instructions on the subject, by passing a reasoned and speaking order within a period of three weeks from the date of receipt of a certified copy of this order. A copy of the speaking order shall be communicated to the applicant within one week thereafter."*

Whereas, in compliance to the directions of the Hon'ble Central Administrative Tribunal Jammu, the case of the applicant was examined in the Department and it has been found that vide Government Order No.188-JK(Edu) of 2024 dated 15.03.2024, Department has extended one time exemption in favour of teaching/other staff of School Education Department, who have acquired higher qualification during service through distance/online mode without obtaining prior permission from the Administrative Department.

Whereas, Committees have been constituted at Directorates levels to verify the genuineness/equivalence of PG degree acquired through distance/on-line mode during the service and eligible incumbents will be considered after the final outcome of the reports of the concerned Committees.

Whereas, vide notice dated 19.02.2024 tentative seniority list of PGMAT in the discipline of Computer Science was issued and applicant namely Mr. Sanjeev Jamwal, is figuring at S.No.52, in said seniority list and the applicant has also acquired PG during his service from IGNOU in distance mode without prior permission from the competent authority.

Whereas, Department has pending regularization of incharge lecturers in various disciplines since the last DPC of 2013 and has already initiated the process for the promotion/regularization. The DPC in the discipline of Computer Science will be conducted very shortly and genuine claim/grievance of Mr. Sanjeev Jamwal including amongst others shall be redressed in the ensuing DPC.

Now therefore, keeping in view, the facts and circumstance of the case and in compliance to the directions of the Hon'ble Central Administrative Tribunal order dated 24.11.2022 passed in OA No. 61/1603/2022 titled Sanjeev Jamwal Vs UT of J&K & Ors, the claim of the applicant is considered
