## Government Order No. 293-JK(Edu) of 2024 Dated: 30.07.2024

Whereas, the Joint Director (I/c Migrants), Directorate of School Education, Jammu vide letter No. DSEJ/Mig/1085 Dated 17.10.2023, has forwarded a copy of Order No. 22(FMCC/MINOR-CORR-CERTS-KD) 2023 dated 05.09.2023 issued by the Jammu and Kashmir State Board of School Education, New Campus-Bemina, Srinagar and requested this department for recording the correct entry of the Date of Birth as 28.02.1965 instead of 29.02.1965 in favour of Smt. Santush Kumari Koul, Teacher, Migrant Cell, Jammu;

Whereas, on perusal of the case based on documentary evidences viz First Page of Service Book collaborates with the Matriculation Certificate issued by the JKBOSE bearing Roll No.26961 under S.No.2265 Session 1980(April-May), and in terms of terms of Rule 35AA (d) of the Jammu and Kashmir Civil Service Regulations. Volume-I, 1956, it comes to fore that the updated date of birth is to be reflected as 28.02.1965 in figures and Twenty Eight February, Nineteen Hundred Sixty Five in words, as non leap year viz 29.02.1965 is existing and reflected in her service records.

Now, therefore, in view of the above, sanction is hereby accorded for establishing the date of birth in her service book as 28.02.1965 instead of 29.02.1965 as non leap year viz 29 02.1965 and allow the corrections wherever occurring in her service record.
