- ii. Compliance to the condition prescribed in the NOCs issued by the competent authorities and in particular, the School Education Department pertaining to Safe transportation of children, boarding/de-boarding arrangements and deployment of personnel for the purpose & also formulation of proper traffic management plan etc.
- iii. Strict compliance to the directions/decisions of the Committee for regulation/Fixation of Fee structure constituted by the Government
- iv. Adherence to terms and conditions of affiliation orders issued by J&KBOSE.
- v. The recognition/up-gradation so accorded is liable to be withdrawn/cancelled in case there is violation or non-adherence to conditions.
