The Terms of Reference (ToR) of the Committee shall be as under:-

2. **Action Plan:** Develop a detailed action plan on various indicators of NEP-2020 for the implementation of NEP 2020, including timelines and milestones.
3. **Stakeholder Engagement:** Facilitate engagement with relevant stakeholders, including government agencies, educational institutions, civil society organizations, and experts in the field of education.
4. **Monitoring and Evaluation:** Establish mechanisms for monthly monitoring progress and evaluating the effectiveness of the implementation efforts, ensuring alignment with the NEP indicators.

5. **Capacity Building:** Identify capacity-building needs and initiatives required to support the implementation of NEP 2020.
6. **Policy Advocacy:** Advocate for policy changes and reforms necessary to align existing education policies with the goals of NEP 2020.
7. **Documentation and Reporting:** Maintain records of all activities, decisions, and outcomes of the NEP Cell, and prepare periodic progress reports for submission to the relevant authorities.
8. **Coordination:** Coordinate with other government departments and agencies involved in education-related initiatives to ensure synergy and avoid duplication of efforts, as per the coordination mechanisms outlined in NEP 2020.
