WHEREAS, the Anti Corruption Bureau vide communication dated 17.01.2019 forwarded a complaint against Mr. Mir Ali, the then I/C Zonal Education Officer, Thatri, Doda to Director School Education, Jammu for conducting inquiry into the complaint;

AND WHEREAS, Director School Education, Jammu got the matter inquired through Departmental Vigilance Officer Doda (Principal Government Higher Secondary School, Bhaderwah);

AND WHEREAS, Director School Education, Jammu vide letter Dated 12.02.2022 forwarded the report/recommendations of the inquiry officer to Administrative Department for further action and vide Government Order No. 254-Edu of 2022, dated 30.03.2022, Mr. Mir Ali, I/C ZEO Thatri was placed under suspension with immediate effect and attached in the office of the Chief Education Officer, Udhampur;

AND WHEREAS, Director School Education, Jammu was directed to nominate an officer for conducting an inquiry into the matter, and vide order dated 21.04.2022, Director School Education, Jammu appointed Mr. Roshan Lal, JKAS, Joint Director (D/K/R), as an Inquiry Officer to conduct an in-depth inquiry into the matter;

AND WHEREAS, the Inquiry officer vide communication Dated 08.06.2022 furnished the inquiry report to the Director School Education, Jammu;

AND WHEREAS, Director School Education, Jammu vide order dated 28.07.2022, constituted a committee of three officers with Shri Dhirender Sharma, JKAS, Joint Director Udhampur/Reasi range as Chairman, Chief Education Officer Doda as Member, and Principal, DIET Doda as Member, to conduct an in-depth inquiry into the matter and the committee submitted its report vide communication dated 17.10.2023;

AND WHEREAS, the report of the committee conveyed that the complainant namely Mohd. Tayoub refused having filed any such complaint, thereby rendering the complaint anonymous;

AND WHEREAS, none of the allegations levelled in the complaint against the suspended officer could be established beyond any reasonable doubt by the inquiries conducted into the matter;

AND WHEREAS, Mr. Mir Ali, the then I/C ZEO, Thathri, Doda retired on superannuation from the service on 31.03.2022, one day after his suspension;

AND WHEREAS, the case was examined and processed in the department and was placed before the Suspension Review Committee and in the meeting of the committee held on 31.05.2024, the case of Mr. Mir Ali, the then I/C ZEO Thathri, Doda (Now retired) was discussed threadbare;

AND WHEREAS, the following decision was taken by the Suspension Review Committee:

a). The committee on the basis of inquiry report recommended that the complaint against the officer has not been proved and established beyond doubt. The officer retired from the services on 31.03.2022 and is without any pecuniary/ pensionary benefits.

b). The committee recommended to reinstate the officer w.e.f.

30.03.2022, and his period of suspension be treated as on duty.

c). If there is any other complaint on record related to other matter that will be inquired separately and action shall be taken accordingly.

NOW THEREFORE, in view of the above stated facts, sanction is hereby accorded to the reinstatement of Mr. Mir Ali, the then I/C ZEO

Thatri, Doda (now retired) w.e.f. 30.03.2022 and the period of his suspension is treated as on duty.
