Whereas, Sh. Anil Sharma (Master), Sh. Bharat Bhushan (Teacher) and Mridhu Bhashni Sharma (Teacher) were placed as I/c Lecturers in the discipline of Chemistry vide Government Order No. 1354-Edu of 2022, dated 31.05.2022 and posted / adjusted to new places:
