Government Order No. 420 - JK (Edu) of 2024. Dated: 10.10.2024.

Sanction is hereby accorded to the temporary appointment of Smt. Rumi Koul D/o Moti Lal Koul W/o Late Sh. Sushil Kumar (Ex-Teacher) R/o Gotingoo, District Kupwara at present village Rehmbal Tehsil & District Udhampur, as Class-IV (MTS) in the District Cadre Udhampur, School Education Department, in the Pay Level SL-1 (14800-47100), under SRO-43 of 1994.

The appointee shall report to the Directorate of School Education, Jammu within a period of twenty one (21) days from the date of issuance of this order failing which she shall forego the right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:-

- 1. Academic/Qualification Certificate.
- 2. Matriculation/Date of Birth Certificate.
- 3. Health Certificate from the concerned Chief Medical Officer of the District.
- 4. Domicile Certificate issued by the Competent Authority.
- 5. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- 7. All other relevant documents as are required under SRO-43 of 1994.

The appointment of the above candidate shall further be subject to the following conditions:-

- (a) The appointee shall furnish an undertaking in the shape of an Affidavit to the effect that:
 - i. There is no criminal record against the appointee.
 - ii. In case adverse report about her Character and Antecedents is received from the Special Director, CID, J&K or an adverse finding subsequent to the V-Roll submitted electronically, she shall have no right to claim her

- appointment as MTS in School Education Department, and her appointment, as such, shall be deemed to have been cancelled ab-initio;
- iii. If, on verification, genuineness of the qualification certificate/DoB and other documents from the concerned issuing authority is found doubtful and fake/forged, the claim of the appointee for appointment as MTS, shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.
- (b) The salary of the appointee shall not be drawn and disbursed to her unless the satisfactory report in respect of genuineness of Qualification/Date of Birth is received from the concerned Authorities/Agency.

(c) The appointee shall be initially on probation for a period of two years.

- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

(f) The appointment order shall be subject to the outcome of any petition/(s) pending in any Competent Court/Tribunal etc.
