Sanction is hereby accorded to the temporary appointment of Mtr. Nuzhat Bashir D/o Late Bashir Ahmad Bhat (Ex- Teacher) R/o Aloosa District Bandipora, as Class-IV (Library Bearer) in the pay Level SL-1 (14800-47100) in School Education Department, District Cadre Bandipora, in relaxation of upper qualification bar in terms of Rule (7) of SRO-43 of 1994, read with SRO-120 of 2018 dated 05.03.2018.

The appointee shall report to the Chief Education Officer, Bandipora, within a period of twenty-one (21) days from the date of issuance of this order and shall be allowed to join only after production of the following documents/certificates (in original) to be verified subsequently:

- 1. Academic qualification Certificate.
- 2. Date of Birth Certificate/Matriculation Certificate.
- 3. Health Certificate from the concerned Chief Medical Officer of the District.
- 4. Domicile Certificate issued by the competent authority.
- 5. Dependent certificate issued by the competent authority.
- 6. All other relevant documents as required under SRO-43/1994.
- 7. No Loan certificate/ No Objection Certificate under self-employment scheme from DIC concerned and Employment Department.
- 8. Category certificate, if any.

The appointment shall further be subject to the following conditions:

- a. That she shall give an undertaking in the shape of an Affidavit to the effect that:
 - There is no criminal records against the appointee.
 - ii. If, on verification, the genuineness of the qualification certificates/Date of Birth Certificate and other documents from the

concerned issuing authority is found take/torged, the appointment as Class-IV shall also be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against her.

- b. The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (i) and (ii) above are received in her favour.
- c. The character and antecedent verification from the CID has been received vide Form No: 112976 dated: 26.11.2024 from the Criminal Investigation Department, J&K, which reveals that there is nothing adverse against the said candidate.
- d. The appointee shall be initially on probation for a period of two (2) years.
- e. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- f. If the appointee fails to join within a period of 21 (twenty- one) days from the date of issuance of this order, she shall forego her right to appointment, which shall be deemed to have been cancelled ab-initio without any notice.
- g. The appointment shall be subject to the outcome of any petition(s) pending in any competent Court of Law/Tribunal etc.
