WHEREAS, Mtr. Rosy, was appointed as Teacher in the erstwhile District Srinagar vide Order No. 842-DSEK of 2007 dated: 10.05.2007 issued by the Director, School Education, Kashmir and was posted by the Chief Education Officer, Srinagar in GHS Pandach, Ganderbal;

AND WHEREAS, in the year 2007 District Ganderbal was carved out from District Srinagar and the official continued to serve in District Ganderbal till date;

AND WHEREAS, the applicant teacher has represented for her transfer from District Ganderbal to District Srinagar on the plea that she is a resident of District Srinagar and was selected in the erstwhile District Cadre Srinagar;

AND WHEREAS, Director School Education, Kashmir vide letter No. DSEK/Estt-III/B-Trs/1722/E-7546358/3364 dated 10.10.2024 has submitted the case of the applicant for transfer to her parent District i.e. Srinagar;

AND WHEREAS, as per the instructions of the General Administration Department conveyed vide OM No. GAD (Adm)65/2012 dated: 10.07.2012, it has been advised that the adjustment of officials appointed against District Cadre posts in the newly created Districts has to be decided on the basis of the domicile factor;

AND WHEREAS, the case was examined in the department and submitted to the General Administration Department for an opinion;

AND WHEREAS, in turn, the General Administration Department vide U.O No. GAD-ADM0III/360/2024-09-GAD (Comp No. 7600261) dated 09.12.2024 has opined as under"

"The department is advised to settle the issue at its own level, in terms of the opinion of the General Administration Department conveyed vide U.O. dated 08.07.2016".

AND WHEREAS, the case was further examined in the department in light of the above opinion of the General Administration Department and from the documents adduced with the file it was established that the applicant is a domicile of District Srinagar;

NOW THEREFORE, sanction is hereby accorded to the transfer of Mtr. Rosy, Teacher, BMS Warpoh, District Ganderbal to District Srinagar along-with the post, with immediate effect. The reconciliation of posts shall be effected between Chief Education Officer, Ganderbal and Chief Education Officer, Srinagar.


