Sanction is hereby accorded to the temporary appointment of Mtr. Shazia Parveen W/o Late Manzoor Ahmed Khan, Ex-Teacher Grade-II, Government Primary School Arrori R/o Kilhotran Tehsil Bhalessa (Gandoh) District Doda, as Class-IV (MTS) in District Cadre Doda (against the post of Class IV/MTS at HSS Kilhotran Doda), in the pay scale SL-1 (14800-47100), in terms of SRO-43 of 1994 read with SRO-120 dated 05.03.2018.

The appointee shall report to the Chief Education Officer, Doda within a period of twenty-one (21) days from the date of issuance of this order, failing which she shall forego her right to the appointment and same shall be deemed to have been cancelled ab-initio without any notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently: -

- i. Academic Qualification Certificates.
- ii. Date of Birth Certificate/Matriculation Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate.
- v. No Loan Certificate/ No Objection Certificate under self-employment scheme from DIC concerned and Employment Department.
- vi. All other relevant documents as are required under SRO-43/1994.
- vii. Category Certificate, if any.

The appointment shall further be subject to the following conditions:

- a) That she shall give an undertaking in the shape of an Affidavit to the effect that:
 - i. There are no criminal records against the appointee.
 - ii. If, on verification, the genuineness of the qualification certificates/Date of Birth Certificate and other documents from the concerned issuing authority is found fake/forged, the appointment as Class-IV shall also be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against her.
- b) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (i) and (ii) above are received in her favour.

- c) The character and antecedent verification from the CID has been received vide Form No: 112976 dated: 26.11.2024 from the Criminal Investigation Department, J&K, which reveals that there is nothing adverse against the said candidate.
- d) The appointee shall be initially on probation for a period of two (2) years.
- e) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- f) If the appointee fails to join within a period of 21 (twenty- one) days from the date of issuance of this order, she shall forego her right to appointment, which shall be deemed to have been cancelled ab-initio without any notice.
- g) The appointment shall be subject to the outcome of any petition(s) pending in any competent Court of Law/Tribunal etc.


