## Government Order No. 79–JK (Edu) of 2024 D a t e d: 18 .01.2024

Sanction is hereby accorded to the temporary appointment of Shri Fardoos Ahmed S/o Lt. Shah Wali Mochi and Lt. Rafiqa Begum R/o Jangalwar, Tehsil & District Doda, as MTS in the District Cadre, Doda, UT of J&K, in the pay level of SL-1 (14800-47100), with immediate effect in the School Education Department, under SRO-43 of 1994.

The appointee shall report to the Directorate of School Education, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate/Matriculation.
- iii. Domicile Certificate issued by the competent Authority.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- vi. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.
- vii. All other relevant documents as are required under SRO-43/1994.

The appointment shall further be subject to the following conditions:-

- (a) That he shall give an undertaking in the shape of an Affidavit to the effect that:
  - i. There is no criminal records against the appointee.
  - ii. In case adverse report about his Character and Antecedents is received from the Inspector General of Police, (CID), J&K or an adverse finding subsequent to the V-Roll submitted electronically; he shall have no right to claim his appointment as MTS in School Education Department, and his appointment, as such, shall be deemed to have been cancelled ab-initio;
  - iii. If, on verification, genuineness of the qualification certificate/DOB and other documents from the concerned issuing authority is found doubtful and fake/forged, the claim of the appointee for appointment



as MTS, shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.

- (b) The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (i) and (ii) above are received in his favour.
- (c) The appointee shall be initially on probation for a period of two years.
- (d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- (e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- (f) All the appointment orders shall be issued subject to outcome of any petition/(s) pending in any Competent Court/Tribunal etc.
